TOURNAMENT RULES

1. NO LIVE BAIT, TROLLING OR JIGGER POLLING PERMITTED. ONLY ONE (1) ROD IN USE AT A TIME.
2. NO FISHING ALLOWED NORTH OF THE SECOND BRIDGE IN WETUMPKA OR PAST THE 231 BRIDGE IN THE TALLAPOOSA RIVER. NO LOCKING THROUGH JONES BLUFF DAM.
3. LIFE VEST WILL BE ON AND FASTENED WHEN BIG MOTOR IS IN OPERATION. KILL SWITCH OPERATIONAL
4. EACH BOAT MUST HAVE LIABILITY INSURANCE.
5. ABSOLUTELY NO ALCOHOLIC BEVERAGES PERMITTED DURING TOURNAMENT ACTIVITIES AND WEIGH-IN.
6. ALL TEAMS MUST CHECK IN, EVEN IF THEY DO NOT HAVE FISH. 12" MINIMUM BY GOLDEN RULE. FIVE (5) BASS LIMIT PER BOAT.
7. PAYMENT OF ENTRY FEE WILL BE CONSIDERED A COMMITMENT. HOWEVER, PARTNERSHIP OR EVEN BOAT UNIT CHANGES WILL BE PERMITTED WITH PROPER NOTIFICATION BEING MADE TO TOURNAMENT DIRECTOR. THIS MAY REQUIRE COMPLETION AND SIGNING OF A NEW ENTRY FORM.
8. REGISTRATION THE DAY OF THE TOURNAMENT WILL BE AT 3:30 AM. BOAT INSPECTION WILL BE AT OR NEAR THE REGISTRATION AREA.
9. IN THE EVENT OF A TIE, PRIZE MONEY WILL BE SPLIT EVENLY.
10. ALL LIVE FISH WILL BE RETURNED TO THE RIVER.
11. A PENALTY OF ONE (1) POUND PER MINUTE WILL BE ASSESSED FOR LATE ARRIVAL TO WEIGH-IN. ALL CONTESTANTS MORE THAN 15 MINUTES LATE WILL BE DISQUALIFIED
12. VIOLATIONS OF THE RULES, CHEATING, OR UNSPORTSMANLIKE CONDUCT WILL RESULT IN DISQUALIFICATION FROM THE TOURNAMENT AND FORFEITURE OF ENTRY FEES. THE DECISION OF THE TOURNAMENT COMMITTEE WILL BE FINAL AND BINDING. ALL CONTESTANTS ARE SUBJECT TO A POLYGRAPH.
13. RULES AND THEIR INTERPRETATION ARE SOLELY AT THE DISCRETION OF THE TOURNAMENT DIRECTORS. DECISIONS ARE FINAL.
14. TOURNAMENT OFFICIALS SHALL HAVE THE RIGHT TO BOARD ANY PARTICIPATING BOAT AND INSPECT LIVE WELLS, BAITS, AND EQUIPMENT. ALL BOATS SHALL BE INSPECTED PRIOR TO LAUNCH. PROTESTS SHALL BE MADE IN WRITING, WITHIN 30 MINUTES OF WEIGH-IN.
15. THE TOURNAMENT BOARD OF DIRECTORS RESERVES THE RIGHT TO RESCHEDULE TOURNAMENT IN CASE OF INCLEMENT WEATHER.
16. IF A PARTICIPANT CHOOSES NOT TO WEIGH FISH, HIS/HER NAME CAN GO INTO A "NO WEIGH POT," AND A DRAWING WILL BE HELD FOR A CHANCE TO WIN BACK HIS/HER ENTRY FEE!
17. ANYONE THAT HAS FISHED IN THE ELITE SERIES WITHIN THE LAST THREE YEARS IS NOT ELIGIBLE TO FISH IN THE SMITH CENTER BASS CLASSIC.
